22 I, Charles Edmunds, declare:

23 1. I am a project manager and a principal of Nerdec, Inc. We have been
24 contracted by Unified Names to handle certain technical aspects of the
25 RegisterFly.com website which includes content/site updates, server administration
26 and site monitoring to name a few specifics. My firm maintains and currently

3 serves as the "webmaster" for www.RegisterFly.com. Unless otherwise stated, I
4 have first hand personal knowledge of the facts set forth herein.

5 2. We were asked by RegisterFly to make some changes to the website
6 on the weekend of May 26, 2007. Being Memorial Day weekend and that our
7 company was closed for this holiday and that I was out of town, these changes
8 were not addressed / implemented until May 29th, 2007 at 5:08am EST by one of
9 our Server Administrators. After making posting the change, we posted a
10 confirmation in the tasks worklog through our Project Management system
11 (<http://projects.nerdec.com>) sent a notification message to RegisterFly to confirm
12 that the changes had in fact been applied and now accessible online.

13 3. On May 29th, 2007, we were asked by Robert O'neill of Unified
14 Names to make an additional change of posting a notice to the top of the home
15 page. Upon researching this requested change, several problems became readily
16 apparent with the way that the web sites coding was implemented that would cause
17 the web site navigation menu on all 4000+ pages to be inoperable and content
18 within those pages to not display / align properly. We informed RegisterFly that, in
19 order to implement this change, we would most likely need to make modifications
20 to reflect across all 4000+ pages.


21 4. I was requested by Registerfly to temporarily post this notice on the
22 customer service page located at <https://registerfly.com/help>. This notice was
23 posted on May 29th, 2007 to the "Customer Service" page in the middle content
24 area.

25 5. While a permanent solution was being researched to enable posting
26 the given notice to the top 1/3 of the homepage, without causing the sites
27 navigation menu inoperable, RegisterFly requested that we post this notice to the
28 bottom part of the home page, a place that would not cause the site to become
inoperable. This change was implemented on June 2, 2007 at 7:46 a.m. After

3 making the change, our Server Administrator updated the task to a completed
4 status through our Project Management system (<http://projects.nerdec.com>) which
5 sent out a notification message to RegisterFly to confirm that the changes had been
6 posted. Attached hereto as Exhibit A is a true and correct copy of that e-mail,
7 created at 9:13:37 AM EST (Sat, 02 Jun 2007 08:13:37 -05:00), indicating that the
8 change had been implemented.

9 6. A permanent solution was found that would enable to message to
10 either be posted to all pages of the web site or the homepage only. To implement
11 this change we would need to make changes to the some of the sites Javascript,
12 CSS and PHP coding. These changes were completed and implemented on the
13 web site on Monday, June 11, 2007, 9:227:57 AM (Mon, 11 Jun2007 08:27:57 -
14 05:00) and were posted to all 4000+ pages. Per the request of RegisterFly, this was
15 placed directly below the main navigation menu of web site.

16 I declare under penalty of perjury under the laws of the United States of

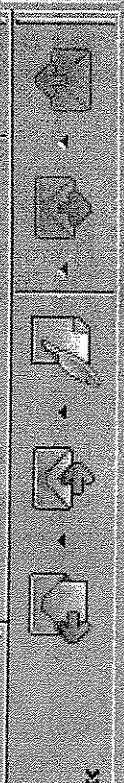


