Dear Lebo Zhou,

Please be advised that as of 10 September 2018, Blue Hi Interconnect (Beijing) Technology Limited Company's ("Blue Hi Interconnect") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 29 September 2015 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 25 September 2018, 15 calendar days from the date of this notice.

The termination is due to Blue Hi Interconnect's failure to timely cure the breach by 7 September 2018 as set forth in ICANN's notice of breach of RAA dated 17 August 2018. As of 10 September 2018, the following breach remains:

1. Blue Hi Interconnect's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Additionally, Blue Hi Interconnect failed to provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that Blue Hi Interconnect will (a) timely respond to ICANN compliance matters and (b) timely make payment of its ICANN fees.

Please see the chronology below for additional details.

Blue Hi Interconnect is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 25 September 2018. Please remove all ICANN trademarks, name and logo from Blue Hi Interconnect's website and business materials that have been licensed to Blue Hi Interconnect under the terms of that Specification by 25 September 2018.

Domain Name Transition Process

No domain names are currently managed by Blue Hi Interconnect. Therefore, ICANN does not need to follow the [De-Accredited Registrar Transition Procedure](#) (“Procedure”).

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Blue Hi Interconnect has past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
