RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT

Dear Aries Ho:

Be advised that the Internet Corporation for Assigned Names and Numbers (ICANN) Registrar Accreditation Agreement (RAA) with Hu Yi Global Information Resources (Holding) Company (Hu Yi Global).

(Hu Yi Global) (IANA No. 1402) is terminated. As explained in greater detail below, this termination is based on Hu Yi Global's failure to cure a financial breach set forth in ICANN's letter dated 30 March 2009. This termination shall be effective fifteen (15) calendar days from the date of this letter, on 25 June 2009.

Hu Yi Global is further advised that the logo license Appendix to the above mentioned RAA is revoked. ICANN demands that Hu Yi Global remove all ICANN Trademarks immediately from Hu Yi Global's website and business materials that have been licensed to Hu Yi Global under the terms of that appendix.

On 30 March 2009, ICANN sent Hu Yi Global a notice of breach of RAA based on Hu Yi Global's failure to pay the accreditation fees, as required by the RAA. Consistent with Section 5.3.4 of the RAA, Hu Yi Global was given fifteen (15) working days to cure this breach. Based on Hu Yi Global's failure to cure this breach within the time period specified by the RAA, Hu Yi Global's RAA is terminated. For your reference, a copy of ICANN's 2 December 2008 notice of breach and a current financial statement are enclosed.

ICANN's records indicate that Hu Yi Global does not have any domain names under management. If Hu Yi Global recently registered domain names, please contact ICANN's Registrar Liaison Manager, Mike Zupke mike.zupke@icann.org, to designate a bulk transfer recipient for the domain names. To facilitate a smooth transition of any domain names currently managed by Hu Yi Global ICANN will follow its De-Accredited Registrar Transition Procedure (Procedure)

http://www.icann.org/en/processes/registrars/de-accredited-registrar-transition-procedur e-01oct08.pdf. We encourage you to read the Procedure in its entirety. Consistent with the Procedure, we are requesting that Hu Yi Global designate a bulk transfer recipient on or before 15 June 2009.

Please note that termination of Hu Yi Global's RAA does not relieve Hu Yi Global of the obligation to pay delinquent accreditation fees, which should be paid immediately. ICANN reserves the right to pursue all means available to collect these fees, totaling \$2,498.12.

It is ICANN's goal to protect registrants from unnecessary harm and we look forward to amicably resolving any domain name transition issues that may arise from this termination.
