**RE: SUSPENSION OF REGISTRAR'S ABILITY TO CREATE NEW REGISTERED NAMES OR INITIATE INBOUND TRANSFERS OF REGISTERED NAMES LIFTED**

Dear Mr. Acir,

We refer to the notice of suspension issued by ICANN to Alantron Bilisim Ltd Sti. (Alantron) dated 16 February 2012 and advise that the suspension is lifted, effective 17:00:00 (UTC/GMC) 6 April 2012.

After checking our records and analyzing data provided by Alantron, ICANN determined that Alantron has cured the breaches cited in the notice of suspension. Accordingly, the suspension of Alantron's ability to create new Registered Names or initiate inbound transfers of Registered Names is lifted.

While ICANN observed that Alantron is now maintaining registration agreement approval records and financial records concerning new registrations, Alantron must confirm to ICANN that it has obtained and retains registration agreement approval records for all of its existing domain name registrations no later than 1 May 2012. Failure to obtain these records and confirm such on or before 1 May 2012 will be deemed a breach of Sections 3.7.7 and 3.4 of the RAA.
