RE: Notice of Termination of Registrar Accreditation Agreement

Dear [NAME REDACTED]:

Please be advised that Planet Online Corp.'s ("Planet Online") Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 13 September 2009 ("RAA") is terminated pursuant to Section 5.3.4 of the RAA. The termination shall become effective 6 July 2012.

The termination is due to Planet Online's failure to timely cure the breaches set forth in ICANN's notice of breach of RAA dated 27 April 2012 http://www.icann.org/en/news/correspondence/burnette-to-zolfonoon-27apr12-en.pdf. As of 12 June 2012, Planet Online's outstanding breaches include:

- Failure to respond to ICANN's 2011 Whois Data Reminder Policy (WDRP) audit as required by Section 3.14 of the RAA; and
- Failure to pay past due accreditation fees as required by Section 3.9 of the RAA.

Please see the chronology below for additional details.

Planet Online is further advised that the logo license Appendix to the RAA is revoked as of 6 July 2012. Please remove all ICANN's trademarks, name and logo from Planet Online's website and business materials that have been licensed to Planet Online under the terms of that Appendix by 6 July 2012. In addition, please pay the outstanding accreditation fees totaling \$13,133.52 immediately.

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by Planet Online.

Consistent with the Procedure, please designate a bulk transfer recipient by 19 June 2012 and inform ICANN's Registrar Liaison Team at RegTransition@icann.org.

Please note that those rights and obligations required or purporting to have effect after expiration of the RAA, including, without limitation, those arising under Sections 3.4, 3.9, 5.6 and 5.7 will survive. Accordingly, Planet Online must pay ICANN any accreditation fees owed by it under Section 3.9 and any enforcement costs under Section 5.7 of the RAA. ICANN reserves all its rights under the RAA.
