

**ccTLD Contributions for FY2018-2019**

The following table summarizes the contributions paid to ICANN from ccTLD registries by contribution year.

The information included in the table below is based upon the ICANN fiscal year for which the contribution was made (as per indicated on the invoices), irrespective of the effective date on which the invoice was

As an example, an invoice issued on 31 July 2017, for a contribution pertaining to ICANN 's fiscal year 2017 (which closes on 30 June 2017), would be reported in the column ICANN FY17, even though the invoice was issued at a date included in ICANN's fiscal year 2018.
