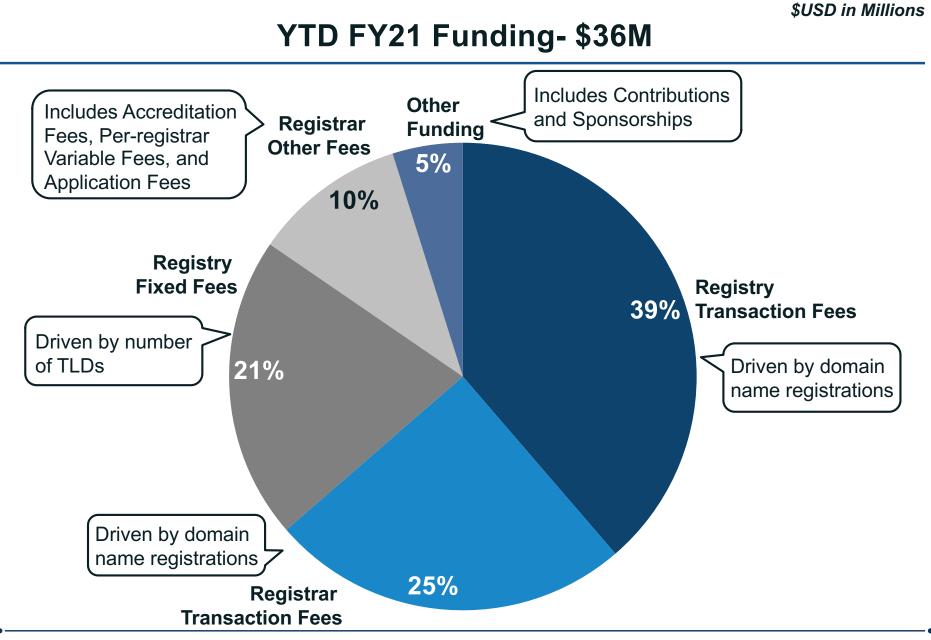

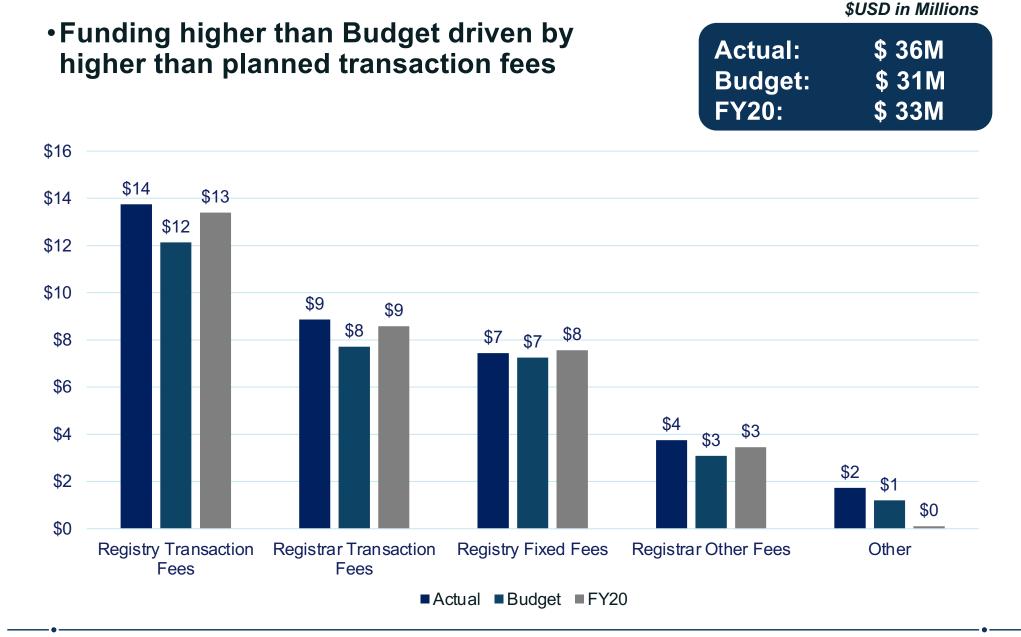

### FY21 (Jul 20 – Sep 20) Funding vs Budget & FY20

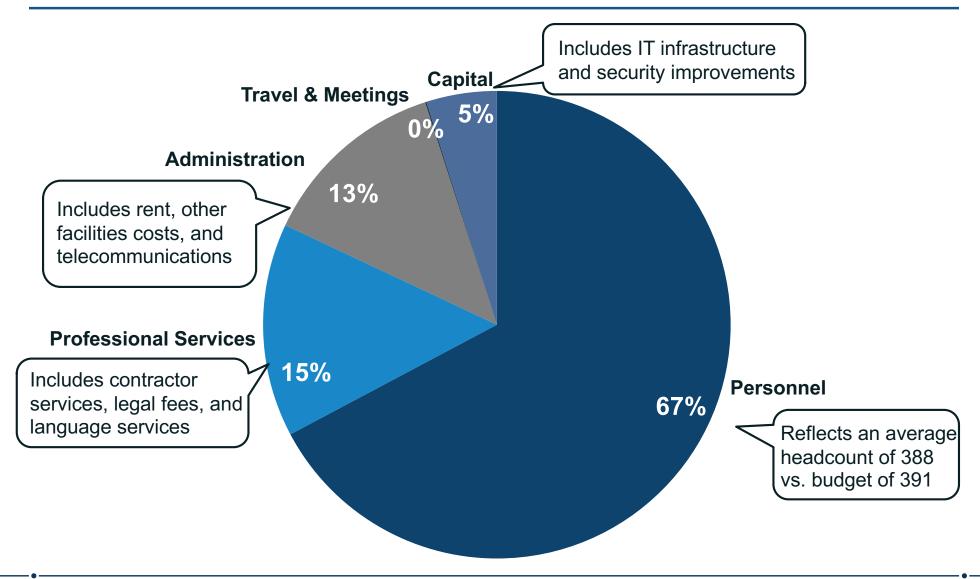

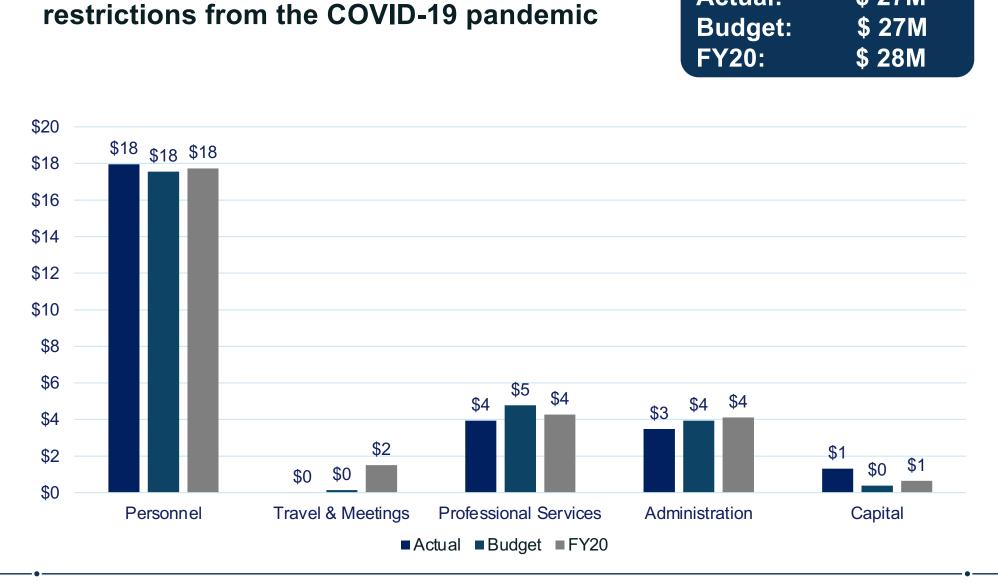

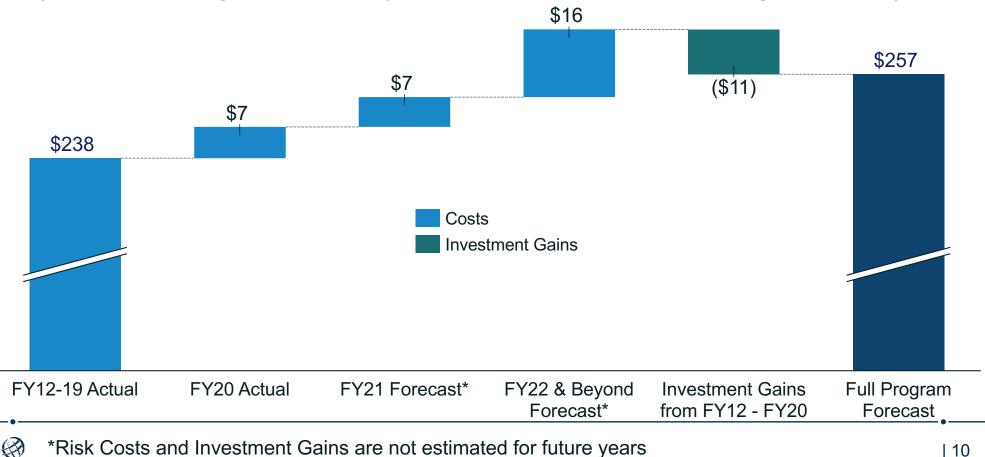

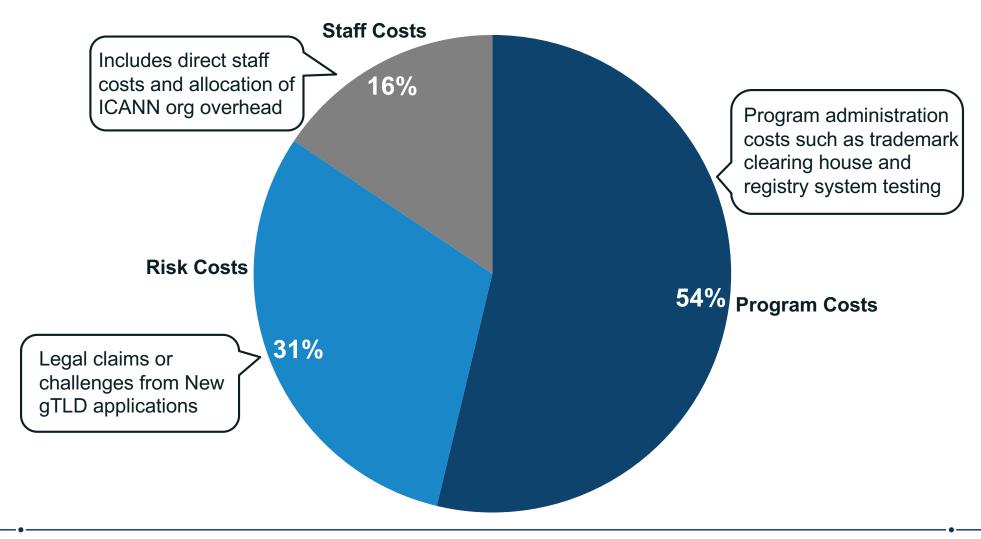
