What is the Fellowship Program?

The goal of the ICANN Fellowship Program is to strengthen the diversity of the multistakeholder model by fostering opportunities for individuals from underserved and underrepresented communities to become active participants in the ICANN community.

Fellows are exposed to the workings of the ICANN community, are assigned a mentor, and receive training across different areas of knowledge and skill building before, during, and after an ICANN meeting. Travel assistance to attend an in-person meeting is also provided.

Main Takeaway from the Virtual Fellowship

Across all the fellows, the ICANN71 Policy Forum offered a valuable opportunity to participate in the ICANN ecosystem.

The fellows found the Prep Week sessions and the special role-play session on the Consensus Policy Playbook particularly useful in gaining real-life experience of the policy development process at ICANN. For some, it gave a deeper insight into the issues that they might come across in their respective nine-to-five, while for others it offered insights into many of the operational processes within the various ICANN stakeholder groups, constituencies and advisory committees.

Some fellows were able to join working group meetings, which helped them contribute directly or observe the policy processes within the ICANN ecosystem. Others had the opportunity to participate in constituency leadership meetings.

The meeting between the ICANN Board and the fellows and NextGen@ICANN program participants was extremely interesting as the fellows and NextGen participants got the opportunity to interact with members of the Board and had the opportunity to ask questions. The overwhelming message for all was the importance and the opportunities for joining the policy development process (PDP) even as newcomers. The conversations with the ICANN Board and ICANN President and CEO were interactive, informative, and left the fellows feeling motivated to do more.

Program Statistics


In this section, the metrics are derived from data provided by fellows during the application process and fellowship post-meeting survey.

Community Engagement


SO/AC Affiliations

Nine fellows have attended regional events sponsored by ICANN.





Fellows participated in ICANN regional team readoust after each ICANN meeting, Africa Engagement Forum, and other outreach events in Africa, the Middle East, and Latin American and the Caribbean.

Policy Development Processes or Cross-Community Activities

Seven out of ten individuals participated in ICANN's policy development process or cross-community activities after their first fellowship. Specifically, fellows participated in the following ways:

ICANN71 fellows have contributed to a public comment including as penholders for their community groups. They participated in Universal Acceptance mailing list discussions and contributed to ccNSO sessions in Latin America and the Caribbean. Fellows have also served as Secretariat and Communications Chair for NPOC, vice-chair for the At-Large Social Media Working Group (AFRALO), and GAC Representative for the Government of Pakistan.

ICANN71 Virtual Fellowship Program Activities

Pre-Meeting Activities

The preparation for ICANN71 differed from previous meetings in that, rather than being brokenup into small groups and doing all the preparation for the Policy Forum within these small groups, all the fellows had a joint meeting once a week with the ICANN fellowship team and the mentors. These meetings were instrumental in laying the foundation of knowledge needed to make the most of the Policy Forum as well as setting the expectations of the fellows. Outside of these meetings, the mentors were available to assist the fellows.

In addition to this, the fellows all had to complete some mandatory courses on the ICANN Learn platform. These courses also provided information that complemented the weekly meetings.

ICANN organizes Prep Week a few weeks before each public meeting to improve community preparation and increase awareness of the plenary topics.

Post-Meeting Activities



The fellows plan to go forward with the skills, information and knowledge they gained during the ICANN71 and use those in their regions to keep standing for the stronger and better Internet.

What is Next?

All ICANN71 fellows are alumni and the majority of them are already engaged in ICANN activities in general and at a regional level particularly. Some participate in policy development through mailing lists. A few are AFRALO members and involved in ccNSO's activities.

ICANN71 fellows describe their further plans for engagement:

Abdalmonem Galila plans to increase engagement with Universal Access activities in the different working groups and engage more with IDN activities through the IDN groups within the GNSO. More involvement in the PDP mitigation of DNS abuse will be considered.

Bonface Witaba will co-convene at the Women School of Internet Governance annual summit in Tanzania, and is planning for a special session for the school's fellows about how to get involved in ICANN (Fellowship and NextGen@ICANN Programs, community engagement, etc).

Bukola Oronti is a member of AFRALO and currently the social media working group vice-chair representing AFRALO. She plans to engage more AFRALO members in the activities of the working group for better publicity of ICANN At-Large. As a member of NCUC/NCSG and NPOC/NCSG, she looks forward to greater participation in these constituencies following the ICANN71 meeting. Bukola also looks forward to having more ICANN engagements with her ALS (ISOC Nigeria) members.

Hanan Khatib will get more involved in DNS abuse control and reduce the damages that it causes.

Jacob Odame-Baiden's goal is to play a very active role in the constituencies that he belongs to. The role-play session during the fellowship program has equipped him with consensus building skills. He believes the skills acquired and other learnings he has received from the ICANN Learn platform places him in a better position to engage meaningfully going forward.

Judith Samantha Tchimmoe Fezeu, attended ICANN meetings and plans to participate as panelist.

Katarina Gevorgyan feels thankful for the opportunity to be a fellow and will take the information and knowledge she gained during ICANN71 to get more involved in ICANN activities and to volunteer on different events and during discussions. She believes these efforts will be useful for her country and the local community to help them better understand the ICANN mission and vision.

Oreoluwa Lesi plans to contribute more during Public Comment processes. She is interested in the work of the new Transfer Policy group and plans to follow their efforts.

Rocio Agustina de la Fuente, because of her role in LACTLD and involvement with the Latin American and Caribbean ccTLDs, worked closely with the ccNSO and its activities after ICANN71. She will definitely continue to be involved with the vibrant and diverse ccTLD community by supporting their work and facilitate engagement activities. She seeks to bring LAC perspectives to the policy development processes and other related activities that take place during ICANN meetings and amongst stakeholders.

Syed Iftikhar Hussain Shah is happy that he attended this ICANN71 Virtual Policy Forum. He actively participated in various sessions at this forum and had the opportunity to ask questions of the experts to gain more clarity and better understand important topics. He plans to participate in future ICANN meetings.
