# Fellowship Program **ICANN79 Overview**

The Fellowship Program strengthens the diversity of the multistakeholder model by fostering opportunities for individuals, especially from underserved and underrepresented communities, to become active participants in the ICANN community. This report represents an overview of the experience of the latest cohort of fellows.

Fellows are exposed to the structure and workings of the ICANN community, assigned mentors, receive training across different areas of knowledge, and participate in skill-building activities before, during, and after an ICANN meeting. Travel assistance to attend an in-person meeting is also provided, where appropriate. Since its inception in 2007, the Fellowship Program has built a strong group of fellows who are actively participating in ICANN communities as well as other entities in the Internet ecosystem.




## **Application Process**

The ICANN organization (org) received three hundred and seventy-eight (378) applications for the ICANN79 Fellowship Program. Initially, forty (40) applicants from thirty-two (32) countries were selected, but due to visa issues thirty-three (33) individuals from twenty-eight (28) countries participated as fellows, with thirty-two (32) in person and one (1) virtual. All thirty-three (33) fellows successfully completed the ICANN79 Fellowship Program.




## **Fellowship Cohort Profile**

Note: The regions reflect the classification adopted by ICANN.





# **Community Engagement**

#### **SO/AC Affiliations**

Fifteen participants (46%) reported affiliation with at least one ICANN community group (SOs, ACs, Stakeholder Group, or Constituency) before the ICANN79 meeting. Six fellows (19%) indicated that their affiliation began following participation in the ICANN79 hybrid meeting. Furthermore, ten fellows (30%) have already identified a community group to join, while two fellows (5%) are still exploring options.

Of the thirty-three (33) fellows, fifteen mentioned their affiliation or interest for further engagement with the ALAC, six with the GNSO, out of them three indicated affiliation with the Non-Commercial Users Constituency (NCUC), five with the ccNSO, four with Security and Stability Advisory Committee (SSAC) and per two fellows with the GAC, Address Supporting Organization (ASO) and RSSAC.



# Main Takeaways from the Fellowship

Below are the main takeaways from the ICANN79 Fellowship Program, as highlighted by the participants:

- Some participants found the preparatory phase enjoyable and expressed appreciation for the mentorship program and the ICANN Learn courses. The courses provided a better understanding of ICANN's structure, work, and various communities, groups, SOs, and ACs.
- Participants emphasized the effectiveness of ICANN's multistakeholder model, which involves governments, businesses, civil society, and the technical community. This collaboration fosters an inclusive decision-making process: building relationships and understanding different perspectives are identified as crucial for collaboration within the ICANN ecosystem.
- Participants highlighted the opportunity to comprehensively understand ICANN's governance structure, mission, outreach programs, and policy development processes. In addition, through interactive sessions and discussions, participants gained deeper insights into initiatives within ICANN groups and their implications on the policy-making process. Furthermore, the opportunity to participate in-person allowed participants to dedicate time to the sessions and, in so doing, gained more meaningful knowledge and experience.
- The fellows expressed gratitude towards meaningful networking opportunities with the ICANN Board and staff, various ICANN community groups, alumni fellows, participating fellows, and other stakeholders. Participants were able to forge valuable connections and exchange ideas, fostering potential collaborations and mutual support within the global community. Additionally, participants expressed that they were able to increase their visibility with the ICANN community and gain new soft skills.
- In light of the dynamic cultural and geopolitical landscape, participants emphasized the need to support ICANN's
  work to adapt and evolve in response to emerging challenges and opportunities. Recognizing the importance of
  inclusivity and diversity, participants stressed the need to ensure that everyone's voice and perspective are heard
  and incorporated into ICANN's decision-making processes. This commitment to inclusivity is essential for promoting
  a stable and secure Internet that reflects the needs and values of all stakeholders, regardless of geographical
  location, language, or cultural background.
- Overall, the experience of the fellowship program and the ICANN79 Community Forum was incredibly positive
  for the participants. They gained new insights, had the opportunity to network and meet inspiring people,
  and felt motivated and empowered. Furthermore, some participants have already found their niche within
  the ICANN ecosystem. Many of them expressed gratitude for the experience and hope to stay involved in the
  ICANN community.







### **ICANN Learn Courses**

The first phase of the fellowship program consisted of the mandatory ICANN Learn courses that were offered through the ICANN Learn online platform, which is built for the global ICANN community. The courses had clear learning objectives and outcomes. They provided the fellows with a basic understanding of what ICANN does and explained how they could get involved with ICANN. The fellows were also offered courses to improve their Internet skills.

## **Mentoring Process**

To fully engage in the fellowship program, each fellow was assigned a mentor as part of a small mentoring team. The fellows' active collaboration and timely responsiveness to the mentors were of utmost importance. During the preparation for the ICANN79 Policy Forum, fellows held joint meetings with their mentors. These online meetings were instrumental in laying the foundation of knowledge needed to make the most of the Policy Forum. They also helped in setting realistic expectations and getting to know each other better.

A virtual meet-and-greet session took place on Friday, February 23, 2024, providing an opportunity for fellows to familiarize themselves with one another. Moreover, the agenda and meeting logistics were communicated during the session.

# Post-Meeting Activities



After ICANN79, participants have a variety of plans and actions they intend to pursue. These plans include deepening engagement by joining specific working groups such as NCSG, NCUC, GNSO, RSSAC, SSAC, APRALO, ALAC, UASG, and others. They plan to actively contribute to policy discussions, technical initiatives, and research activities within these groups.

Additionally, some participants aim to offer technical support as website administrators for various ICANN groups, ensuring the smooth functioning of online platforms and supporting research initiatives. Others express their commitment to advocating for specific issues such as Internet security, digital rights, Domain Name System (DNS) abuse prevention, and Universal Acceptance (UA) of domain names and email addresses. They plan to actively participate in policy development processes within ICANN and collaborate with relevant stakeholders to address these issues.

Many participants also focus on educational initiatives, aiming to raise awareness about ICANN's work, Internet governance, and technical aspects such as Domain Name System Security Extensions (DNSSEC) and UA. They intend to organize workshops, webinars, and courses to educate their communities and encourage participation in ICANN programs.

Some of the fellows also initiated a conference call with a youth group in Africa called Pan African Youth Ambassadors for Internet Governance (PAYAIG) to advise newcomers on how they can delve deeper into and apply for the ICANN fellowship. The goal is to share the insights and experiences gained from the fellowship. Additionally, the participants had an engaging session with At-Large, which proved valuable in providing an overview of the fellowship and brainstorming ways to enhance the fellowship experience.


Networking and collaboration within the ICANN community are also key priorities for many participants. They plan to build partnerships, share knowledge and insights, mentor newcomers, and contribute to a collaborative and inclusive Internet ecosystem. Some participants highlighted the importance of regional engagement, such as representing their regions within ICANN structures such as the European Regional At-Large Organization (EURALO), Latin American and Caribbean Islands Regional At-Large Organization (LACRALO), North American Regional At-Large Organization (NARALO), African Regional At-Large Organization (AFRALO) and Asia Pacific Regional At-Large Organization (APRALO). They aim to amplify the voices of underrepresented communities and promote regional-specific initiatives.

Many participants see their involvement in ICANN as a means of professional development. They plan to enhance their skills, gain expertise in specific areas, for example, Internet governance, cybersecurity, and technical operations, and pursue leadership roles within the different ICANN structures. Overall, participants are committed to advancing ICANN's mission to ensure a stable, secure, and unified global Internet.

As depicted in the chart below, the fellows expressed strong appreciation for the hybrid format of the ICANN79 Community Forum, particularly the chance to participate in in-person sessions.



## Feedback on Prep Week Meeting Activities

The ICANN Prep-Meeting leading up to ICANN79 provided fellows with a valuable platform to share their perspectives and insights. Fellows expressed appreciation for the opportunity to engage in meaningful discussions and exchange ideas on various topics relevant to Internet governance and ICANN's upcoming activities. They found the sessions to be informative and conducive to building relationships with fellow participants. Fellows also highlighted the significance of mentorship in their learning journey. Mentors played a crucial role in guiding them through unfamiliar concepts and providing valuable insights into the inner workings of ICANN and Internet governance. The personalized support and encouragement from mentors enabled the fellows to navigate challenges and gain confidence in their abilities.

As the fellows progressed through the learning course, they were encouraged to actively participate in discussions, ask questions, and seek clarification on any concepts they find challenging. The course provided a structured approach to learning, with modules covering various aspects of Internet governance, ICANN's role, and relevant policy developments.

#### Below are some fellows' suggestions for improvement:

## **Areas of Opportunity to Improve the Newcomer Experience**

With a profound emphasis on equipping participants with the necessary tools and engagement procedures, the ICANN Fellowship program aims to deeply immerse fellows in the operational intricacies of ICANN and its affiliated groups and communities. Recognizing this imperative, ICANN is committed to cultivating a diverse and vibrant community of stakeholders who can collectively address the complex challenges and opportunities facing the Internet. Therefore, the fellows put forward the following recommendations for consideration:

- Fellows with experience in ICANN should be given the opportunity to choose sessions they are interested in, instead of being required to attend mandatory newcomer sessions, especially in the case where sessions clash.
- Create a space for second and third-time fellows to share their accomplishments and encourage newcomers to work towards achieving the same and more.
- Newcomers should receive guidance by their mentor about which group they should join.
- Review the logical and effective continuity of the ICANN Learn courses to avoid repetition.
- Second- and third-time fellows should be given a research topic based on what ICANN is working on ("hot topics") and be given a session to present their findings at the meetings.
- Implementing a buddy system where newcomers are paired with an alumni fellow could give newcomers a chance to gather information and confidently ask questions while forging relationships.
- Mentors could have more assignments and periodic evaluations of their mentees, even in the preparatory phase, so that they could have time to help them before meeting.
- The fellowships team should consider introducing live virtual sessions with relevant SOs and ACs before the meeting. This could provide a more interactive and in-depth understanding of the complex ICANN ecosystem, making the meeting experience even more enriching for newcomers.
- Preparatory work should begin earlier, or alternatively, fellows should have the option to arrive a day or two in advance to acquaint themselves with the surroundings. This would facilitate meetings with their mentorship teams and allow discussions on how best to engage throughout the week.
- During onboarding, it would be beneficial to inform the fellows that they should always pick up their headphones when entering a room and they should also receive instructions on how to use them effectively.
- Improving the newcomer experience at ICANN meetings requires offering comprehensive orientation sessions, hosting interactive workshops, facilitating networking opportunities, encouraging feedback for continual improvement, and developing online resources to supplement learning.





# What is Next?

The ICANN79 Fellowship program brings together a dynamic group of alumni with diverse backgrounds and interests. Many of our fellows are keen to continue their engagement in policy development initiatives. They actively participate in various ICANN community groups at regional levels and maintain close communication with ICANN's regional engagement team. A significant number of fellows have already pinpointed specific groups they wish to join, while others are enthusiastic about becoming involved in local chapters of the Internet Society.

Furthermore, some fellows are actively contributing to policy development discussions through mailing lists and holding memberships in Regional At-Large Structures. They are expecting that At-Large leadership should engage the fellows in any new upcoming policy related project within their respective regions, enabling fellows to contribute to the development of such policies from scratch. Moving forward, here's a glimpse of the plans our ICANN79 fellows have for further engagement within ICANN and the broader Internet governance ecosystem:

#### **ABRAHAM SELBY**

Drawing from my background in public policy, Internet governance (IG) and web development, I've been actively involved with various stakeholder groups as a volunteer, leveraging my expertise to assist them. My contributions extend to engaging in discussions pertaining to IG, domain name policies, and technical standards. Looking ahead, my commitment to ICANN remains steadfast, with a focus on deepening my comprehension of global IG matters and actively contributing to the formulation of inclusive and effective policies. Additionally, I aim to offer technical support as a website administrator for the NCUC, AFRALO, UASG, and other working groups, ensuring the smooth functioning of their online platforms and supporting research initiatives. As a member and faculty of the Pan African Youth Ambassador for Internet Governance, I aspire to enhance the participation of our peers by encouraging them to join ICANN through initiatives like the ICANN Learn and Newcomers program.

#### **ALYZA JOSEF**

My participation at ICANN has consisted of observing as well as active engagement during the sessions. This has allowed me to learn about the multistakeholder model in practice, engaging with all types of stakeholders from different sectors and countries. The fellowship program has allowed me to explore the various ICANN Constituencies and their missions. My future plans with regards to ICANN are therefore to further explore these constituencies to find the one that fits me best. Additionally, I would like to continue to participate in ICANN meetings and e-mail discussion lists to keep up with ICANN's tasks, discussions, and accomplishments. At last, I would like to mention the warm, open community that is ICANN. I was surprised at how the bottom-up approach is implemented in practice, demonstrating that all ICANN members were open to questions and discussions about certain topics. This has really helped me in the fellowship process.
