Technical description of Proposed Service:

We, as FRL Registry, would like to get permission to register LC.FRL in our TLD. The reason for this is that we have a newspaper in the region we target with our TLD that has the name Leeuwarder Courant. They now use lc.nl as their primary domainname. Because of our registry agreement we're not permitted by default to register two-letter domainnames within our TLD without permission of the country that \"holds\" this two-letter string or by demonstrating that we prevent confusion for the end-users. As we have a very specific target user for this two-letter domainname which is a newspaper targeting primarily our region we think we prevent confusion with the St. Lucia country-code.

We have tried to reach the responsible countrycode-owner (St Lucia) several times but they simply don't react to any emailcontact. We tried reaching them through emailaddresses mentioned on the www.nic.lc website, the contact-data on the ICANN-site and even departments of the government website of st. Lucia. We even have tried to reach them through their Registry Service Provider. As we got no response whatsoever, we now try the alternative option through the ICANN-board.
