RE: NOTICE OF SUSPENSION OF REGISTRAR'S ABILITY TO CREATE NEW REGISTERED NAMES OR INITIATE INBOUND TRANSFERS OF REGISTERED NAMES

Dear Murat Yaniklar,

This notice is sent to Reg2C.com Inc. ("Reg2C.com") further to its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 13 September 2014 ("RAA").

Pursuant to Section 5.5.4 of the RAA, Reg2C.com failed to cure breaches of the RAA within 21 days after ICANN issued Reg2C.com a notice of breach on 13 August 2018.

Reg2C.com's ability to create new Registered Names or initiate inbound transfers of Registered Names is suspended for 90 days pursuant to Section 5.7 of the RAA.

The suspension is effective 30 September 2018 at 00:00 UTC and will conclude on 29 December 2018 at 00:00 UTC, or longer if Reg2C.com has not demonstrated compliance on or before 8 December 2018.

Consistent with Section 5.7 of the RAA, during the suspension period, Reg2C.com must not:

- 1. Create new Registered Names for any generic top-level domain ("gTLD"); or
- 2. Initiate or accept inbound transfers of Registered Names for any gTLD.

To demonstrate compliance, Reg2C.com must timely cure all breaches identified in this notice of suspension by:

- 1. Providing ICANN with corrective and preventative action(s), including implementation date(s), to ensure that Reg2C.com will:
 - a. timely respond to ICANN compliance matters:



- b. timely make payment of its ICANN fees; and
- c. remain in compliance for previously remediated areas of noncompliance; and
- 2. Paying all past and currently due accreditation fees.

Failure to demonstrate compliance by 8 December 2018 may result in RAA termination and an extension to Reg2C.com's suspension pending final termination.

Notice on Reg2C.com's Website

During the suspension period, Reg2C.com must prominently display the following on its website on all pages where Registrar Services, as defined by the RAA, are offered:

No new gTLD registrations or inbound transfers will be accepted from 30 September 2018 through 29 December 2018.

This notice must also include a link to the notice of suspension from ICANN.

Please be advised that Reg2C.com may be subject to escalated compliance action (including RAA termination) if ICANN receives additional information, either through complaints or its own monitoring, demonstrating that Reg2C.com continues to violate the RAA or Consensus Policies, including failure to timely pay accreditation fees, during or after the suspension period.
