Dear James Archer,

Please be advised that as of 15 November 2018, SaveMoreNames.com Inc.'s ("SaveMoreNames.com") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 6 July 2015 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 30 November 2018, 15 calendar days from the date of this notice.

The termination is due to SaveMoreNames.com Inc.'s failure to timely cure the breach by 14 November 2018 as set forth in ICANN's notice of breach of RAA dated 24 October 2018. As of 15 November 2018, the following breaches remain:

- 1. SaveMoreNames.com's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA; and
- SaveMoreNames.com's failure to publish its Registrar Information Specification ("RIS")
 correspondence address on SaveMoreNames.com's website, as required by Section
 3.17 and Section 7 of the RIS of the RAA.

Additionally, SaveMoreNames.com has failed to:

- Confirm whether the full name and position of the officers displayed on SaveMoreNames.com's website are applicable to SaveMoreNames.com and if so, update SaveMoreNames.com's RIS form to reflect the information displayed on SaveMoreNames.com's website;
- 2. Confirm SaveMoreNames.com's compliance with the data escrow requirements of Section 3.6 of the RAA and provide explanation to address the inconsistent number of second level domain names noted in the notice of breach; and



- 3. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that SaveMoreNames.com will:
 - a. timely and fully respond to ICANN Contractual Compliance matters; and
 - b. timely make payment of its ICANN fees.

Please see the chronology below for additional details.

SaveMoreNames.com is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 30 November 2018. Please remove all ICANN trademarks, name and logo from SaveMoreNames.com's website and business materials that have been licensed to SaveMoreNames.com under the terms of that Specification by 30 November 2018.

Domain Name Transition Process

No domain names are currently managed by SaveMoreNames.com. Therefore, ICANN does not need to follow the <u>De-Accredited Registrar Transition Procedure</u> ("Procedure").

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

SaveMoreNames.com has current and past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
